As part of the implementation of Green Tamil Nadu Mission, the request for Expression of Interest is invited from the experienced Organization/ Non Government Organizations / Consultants for taking up the following work.

1. Engaging of state Level coordinator under the Green Tamil Nadu Mission for two years.

Under Green Tamil Nadu Mission, the Expression of Interest (EOI) is invited for engaging the State Level Coordinator for two years under the Green Tamil Nadu Mission. Details of this Expression of Interest is available in the Web portals www.greentnmission.com and www.tnforests.nic.in

The, interested Organization/ Non Government Organizations / Consultants may offer their proposal within 10 days.

Details of the organization, past experiences, registration with legal authorities and other relevant details are invited. The details may be sent to this office on or before 10-06-2023.

The proposals will be examined and the outcome will be intimated about the terms and conditions of the work, after the approval of the Government of Tamil Nadu

2. SCOPE OF WORK:

The scope of work includes:

1. To develop liaisons with all Government Departments, Non Government Organizations, farmers, corporate bodies, private institutions, public and other multi stake holders up to the panchayat level in the State of Tamil Nadu for effective co ordination and implementation of the objectives of the Green Tamil Nadu Mission.

2. Listing and Nomination of 6 (six) No. of zonal level coordinators to have liaison with at least six to seven districts up to the panchayat level in consultation with Green Tamil Nadu Mission.
3. The publicity and awareness among the public and stakeholders up to the panchayat level.
4. Co ordination with District Green Committees in each district in the identification of the beneficiaries and land parcels in all the districts.
5. The geo tagging of land parcels, collection and uploading of all the details related to the Mission.
6. The collection and uploading of high resolution photos and videos of the nursery, planting and other related activities of the entire districts involving all the stakeholders such as all Government Departments, Non-Government Organizations, farmers, corporate bodies, private institutions, public, etc.,
7. Mobilization of funds from various stake holders as per the guidelines for the implementation of the Green Tamil Nadu Mission on the lines of Namakku Nammē Thittam promoting voluntary plantations by the corporate sectors, the NGO's and the individuals in the Green Tamil Nadu Mission.
8. The prevention of duplication of planting works in the districts through consultation with District Green Committees.
9. To ensure wider participation of all the Public, Government Departments, NGOS, Trusts, Private Institutions in order to make the Green Tamil Nadu a people's movement.

2. Duration of the work:

The State Level Coordinator and Zonal Level Coordinators so nominated will be engaged for the initial duration of two years only. The said engagement shall be purely performance based and the State Level Coordinator and Zonal Level Coordinator can be replaced in case of lack of quality performance. The eligible honorarium of about Rs.22,000 / month shall be paid to the State Level Coordinator and about Rs.15,000 / month shall be paid to each Zonal Level Coordinators

respectively as decided by the Green Tamil Nadu Mission. The engagement is purely on temporary basis subject to the decision of the Green Tamil Nadu Mission.

3. SUBMISSION OF EOI

The EOI for the engaging State Level Coordinator under the Green Tamil Nadu Mission should reach the address given below on or before 10th June, 2023 before 5 p.m. The EOI should contain brief details of the Organization / Consultant's profile including previous experiences.
